Black Loyalist Heritage Centre - Grand Opening

"The story of the Black Loyalists -- how they served the British in the war in exchange for the promise of freedom in peacetime, and how they travelled to Nova Scotia only to endure hardships of slavery, indentured servitude, landlessness and hunger -- is one of the great stories of Canadian history." (Lawrence Hill)

The Black Loyalist Heritage Society (BLHS) is pleased to announce that the grand opening of the Black Loyalist Heritage Centre (BLHC) will be held on June 6, 2015. Visitors will learn and experience the story of the largest and most influential communities of free Black people in the world, outside of Africa, from 1783 to 1791 in Nova Scotia.

John Franklin, Senior Manager, National Museum of African American History and Culture, Smithsonian Institute as well as the author of the novel "The Book of Negroes", Lawrence Hill will be keynote speakers at the grand opening of the BLHC.

Mr. Franklin will be speaking to the students of Shelburne Regional High School (SRHS). As part of the grand opening celebrations, the BLHS will host an intimate evening with Lawrence Hill to discuss the novel and mini-series, "The Book of Negroes". Mr. Hill will also be speaking with SRHS students.

DO I NEED A PERMIT FOR THAT?



Confused? Here are a few facts.
Permits are required for:

- New building construction
- All additions
- Any structural changes
- Relocation of an existing structure
- Changing the use of the building
- All sheds, garages and accessory buildings
- Decks – replacing, new or roofed
- Alterations & renovations
- Demolitions

If you are prepared, obtaining a permit is as easy as 1,2,3.
All you need is:

1. **General Information:** Your name, mailing address, civic address, phone number, contractor's name and contact information, etc.
2. **Building Plans:** This is a set of plans of the work to be completed, including layout, footing and foundation details, floor, wall and roof assembly details, insulation and vapour barrier details as well as exterior and interior finish details.
3. **Possible approvals from other departments:** If you require driveway access and/or you are constructing within 60 meters of the limits of the roadway, you will need approval from the NS Dept. of Transportation and Infrastructure Renewal (NSDOTIR). If an on-site sewage system is required, you will need approval from the NS Dept. of Environment (NSDOE). Their contact information is available on our website.

The cost of a permit varies depending on the project.

On average, once you have submitted a completed application form, provided plans, approvals and fees are paid, it will take approximately five (5) days for the application to be reviewed and processed.

Always remember - Permits are mandatory and important. Building permits provide the means for Building Officials to ensure the health, safety and welfare of building occupants. You have a major investment in the home or business you are about to build or remodel.

Applying for a permit ensures the Nova Scotia Building Code Regulations are met.

If you choose to start building without a permit, please note that the owner and contractor shall be liable to fines beginning at \$693.95 (for individuals) and \$1268.95 (for corporations) and the possibility of any completed work being removed.

Rules & Regulations

A By-Law Briefing

The goal of the By-Law Enforcement Department is voluntary compliance of the various by-laws that apply to the residents of the Municipality. All by-law reports are confidential; residents are encouraged to report non-compliance.

Solid Waste By-Law - illegal disposal/dumping, burning, burying, and curbside violations. The Municipality supplies sorting guides, compost carts and has a Waste Diversion Coordinator to assist and educate any resident that may have a question about the proper disposal of solid waste.

The **Dangerous or Unsightly Premises Policy** deals with properties that have fallen into disrepair and become either dangerous or unsightly. There is an established criteria and procedure for dealing with such properties. There are presently several open and active files.

The **Dog By-Law** deals with issues such as dangerous dogs, dogs barking or dogs running at large. The Province has recently adopted Standards of Care guidelines that are enforced by the SPCA.

The Municipality has a separate **Animals at Large By-Law** that deals with livestock - cattle, horses, ponies, mules, sheep, swine, goats and poultry. This By-Law sees a fair amount of action with these animals running at large.

Shedding some light on Streetlights

In 2011, Provincial legislation directed that all roadway lighting be changed to LED lights as part of its overall energy reduction program and its commitment to use energy efficient roadway lighting. The Municipality is responsible for over 1,200 streetlights and has been exploring ways to reduce both its street lighting costs (approximately \$200,000 annually) as well as its carbon footprint. Last year, the company Black & MacDonald, was hired to review all streetlights located within the Municipality and to provide a recommendation regarding potential improvements, including the removal of unnecessary lights, without compromising the safety of our residents.

It is anticipated that approximately 120 streetlights will be removed from the Municipality's streetlight inventory, which will help us reduce our environmental impact and costs. The Municipality will also work with NSPI to prepare a streetlight wattage design program for light consistency throughout our communities.

The Best Accident Never Happens

The role of the Emergency Measures Organization (EMO) for your area is to ensure that a coordinated and managed response takes place when a disaster of severe proportions occurs that overwhelms the normal response agencies. You, a resident of this community, can ensure that this happens in a controlled manner by taking steps to guard against you, your family or your residence being impacted by a severe storm, fire or other event. While it is understood that you cannot protect everyone from everything, you certainly can take steps to minimize damage and risk.

With the coming Spring, it is a good time to plan your warm weather activities. What better time to prune limbs or maybe even eliminate diseased trees that may cause damage in a hurricane.

With Spring also comes a lot of rotating machinery (lawnmowers, chain saws, whipper snippers, tractors and ATVs). Through management, supervision and proper use of the tool involved you can prevent an accident. The largest source of accidents is failure to use or the improper use of safety equipment.

Safety is everyone's business. Indeed it is the law. No one can ask anyone to do something that is unsafe. If you see an appliance with a frayed power cord, after making sure it is unplugged, cut the cord off - it may save someone's life. Many community halls and businesses are purchasing and installing defibrillators. Learn how to use them. They may keep the patient alive until an ambulance arrives.

Finance

Municipal Property Tax Bills will be sent out by mail at the beginning of April with a due date of May 31, 2015. The April "interim bill" will reflect 60% of the previous years' total tax. The September "final bill" will make up the balance of the current years' taxes based on the current assessment and tax rate.

The 2015 Low Income Property Tax Exemption deadline for applications isn't until August 31, 2015, but its tax season now. If your household income was less than \$20,000, you could be eligible for a tax exemption of up to \$300. Please send in or drop off a copy of your **2014** Notice of Assessment from Revenue Canada to the Finance Department.
